Subject: Revision of pension of pre-01.01.2006 pensioners--

Sir/Madam,

Kindly refer to this department OM No. 2/51/2008-1 Pension, dated 06.02.2015 vide which it was decided to step up pension **up to 50% (fifty percent)** and family pension upto **30 % (thirty percent)** respectively (w.e.f. 06.02.2015) of the sum of minimum of pay in the pay band and the grade pay (including HAG scale) corresponding to the pre-revised pay scale from which the pensioner had retired, as arrived at with reference to the fitment tables annexed to the Finance Department's (Pay Revision Branch) letter No. 1/83/2008-1PR(FD) dated **07.01.2009/27.01.2009**.

2. In the para 9 of above OM, all the Pension Disbursing Authorities were requested to revise the Pension/Family Pension of the pre-1.1.2006 pensioners as per provision contained in that OM.

3. A number of references were received from the Pension Disbursing Authorities to issue guidelines to all HODs for revision of pension/family pension as per above OM dated **06.02.2015 as relevant data** of retirees are not available with them.

4. After due consideration, it has now been decided by State Government that all pre 1.1.2006 pensioner/family pensioner will made request to department concerned for revision of pension/family pension (as the case may be) in the following format and department will forward the same to Pension Disbursing Authority/Treasury Officers concerned:-



I am directed to invite a reference to Finance Department circular letter No. 4/1/2009-5FR/23388 dated 13th November, 2014 on the subject noted above and to say that the Governor of Haryana is pleased that the Dearness Allowance payable to Haryana Government employees on revised scales of pay shall be enhanced from the existing rate of 107% to 113% of the pay w.e.f. 1st January, 2015.

2. The additional instalment of DA payable under these orders shall be paid in cash to all Haryana Government employees for the month of May, 2015 paid in June, 2015.
3. The payment of arrears of enhanced Dearness Allowance for the month from 01.01.2015 to April, 2015 shall be made in the month of June, 2015.
