

Consequent upon revision in the Toll Charges by N.H.A.I other agencies and in continuation of order No. 13/44/2002-67(II) dated 5.3.2003, the Toll Road User Charges applicable to passengers of Haryana Roadways buses for more than 30 Km travel, are hereby revised. The charges shall be recovered from the passengers travelling on buses of Haryana Roadways on toll roads as per the schedule of rates given below:-

Distance Travelled by the passengers on Road on which user charges are imposed (In Km)	Rate of toll tax to be charges (In Rs.)
1 to 15	Nil
16 to 25	1.00
26 to 30	2.00
31 to 50	3.00
51 to 70	4.00
71 to 90	5.00
91 to 110	6.00
111 to 130	7.00
131 to 150	8.00
151 to 170	9.00
171 and above	10.00

These orders will come into force from 01.08.2008.


